We offer incredibly competitive rates on our Finance Lease products.

2) Hire Purchase. Under an HP Agreement, you hire the van and then pay an agreed amount by instalments. Once all payments have been made, you will own the van. There is no balloon payment at the end of the agreement. You can settle the agreement at any time.

3) Contract Hire. This is a leasing finance option, available to sole traders, partnerships and limited companies. It represents an agreement between two parties to lease a vehicle for a set time period (and mileage) at a fixed monthly cost.
